# Fire Door Inspections

### **1. Introduction**

- 1.1 Fire resisting doors are one of the most important measures to safeguard the means of escape from fire. Fire doors are often the first line of defence in a fire and the correct specification, maintenance and management can significantly influence the outcomes should a fire start in a building. As with all fire safety measures, fire doors need to be kept in good working order and in good repair.
- 1.2 However, fire doors remain a significant area of neglect, often the first thing to be mismanaged throughout their service life, propped open, damaged, and badly maintained. This makes fire door breaches one of the most common areas for enforcement action under the Regulatory Reform (Fire Safety) Order 2005 and Fire Safety Act 2021 in England and Wales; the Fire (Scotland) Act 2005; and/or Fire Safety Regulations (Northern Ireland) 2010. The Fire Safety (England) Regulations 2022 made it a legal requirement from 23 January 2023 for responsible persons for all multi-occupied residential buildings in England with storeys over 11 metres in height to:
  - undertake quarterly checks of all fire doors (including self-closing devices) in the common parts;
  - undertake on a best endeavour basis annual checks of all flat entrance doors (including self-closing devices) that lead onto a building's common parts.

The regulations also require responsible persons to provide to residents of all multi-occupied residential buildings with two or more sets of domestic premises (that have common parts) information on the importance of fire doors to a building's fire safety.

The checks required under the regulations do not replace the existing duty under the Fire Safety Order for the responsible person to put in place general fire precautions and their duties under Article 17 of the Fire Safety Order in all buildings which are in scope of the Fire Safety Order, regardless of height.

## 2. William Martin's Approach

  - Fire Door Inspections containing reports for individual fire doors including photographs, locations, and the levels of compliance.
  - Protocol confirming the fire door inspection methodology and reference to appropriate British Standards and Statutory Guidance.
